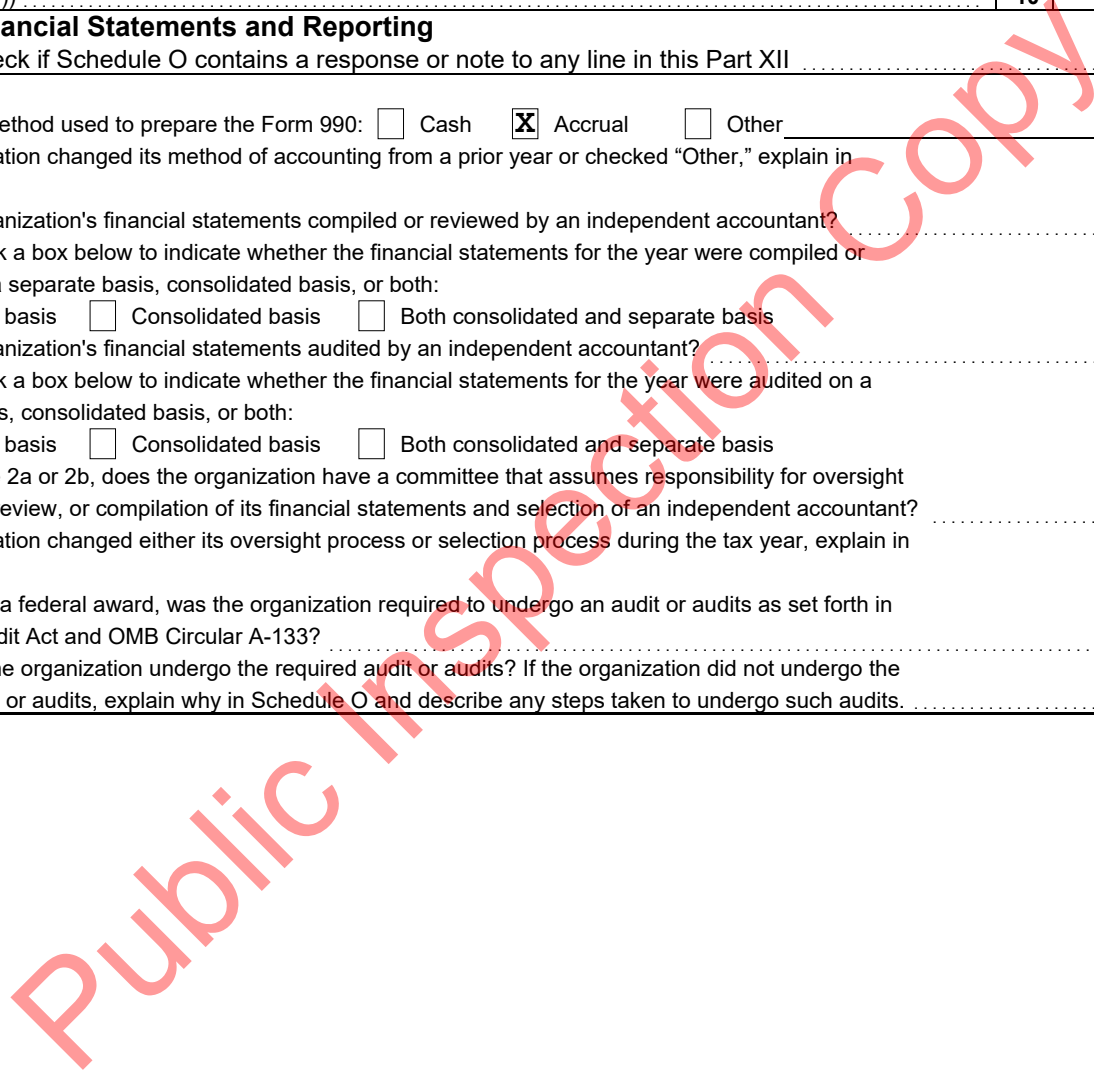

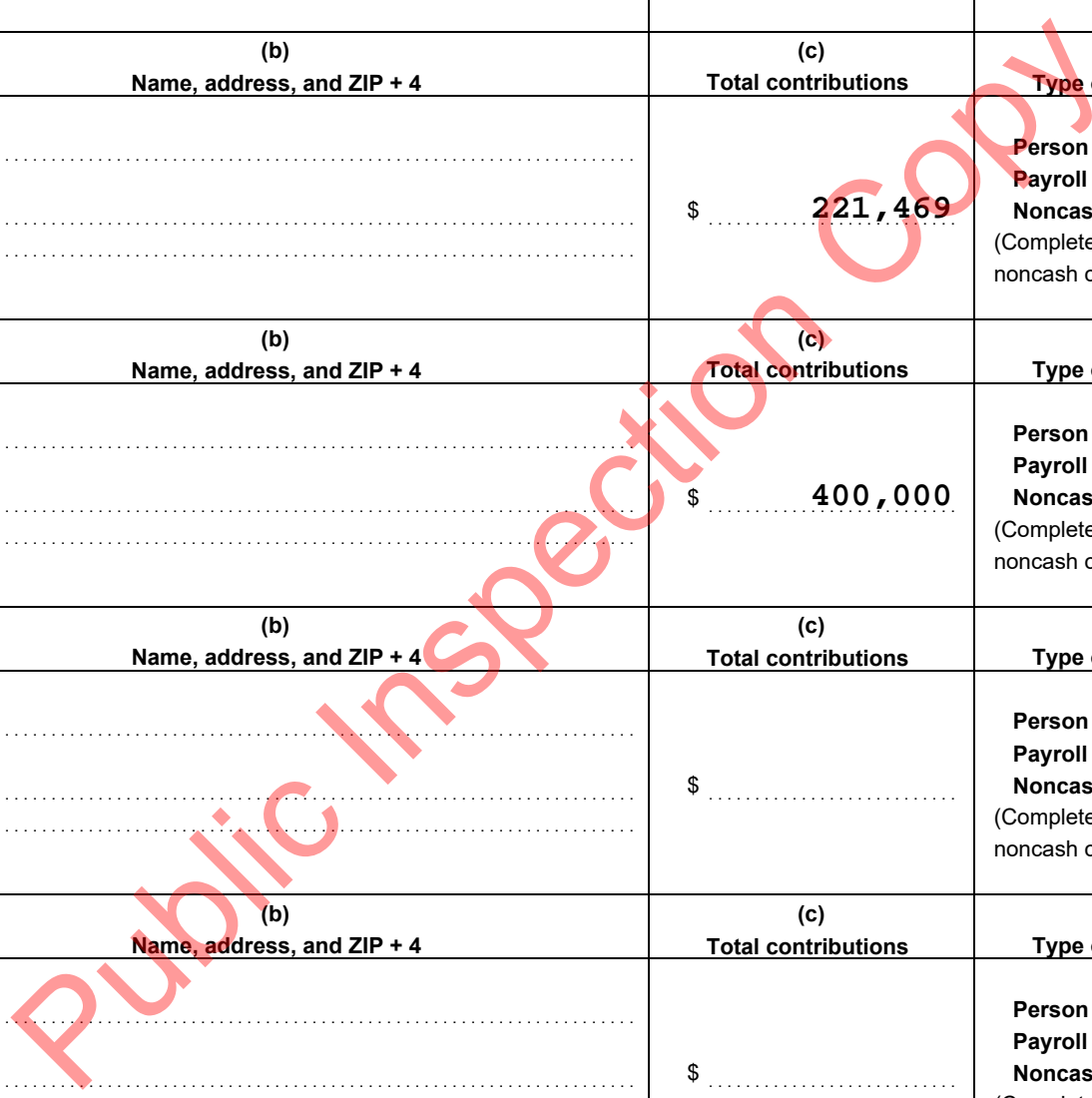

BY UTILIZING THESE GRANT FUNDS, NICOA EXPECTS TO IMPACT INDIAN COUNTRY WITH IMPROVED KNOWLEDGE OF SERVICES AND SERVICE ELIGIBILITY AMONG ELDER, IMPROVE COMMUNICATION BETWEEN TRIBAL LEADERSHIP AND TRIBAL ELDER ABOUT RESOURCE ALLOCATION FOR PROGRAM AND SERVICE DEVELOPMENT, AND STRENGTHEN NICOA'S POSITION IN INDIAN COUNTRY AS THE PREMIER ADVOCATE FOR AI/AN ELDER ISSUES.
